5. The <b>LESSEE</b> will be responsible for transporting the equipment.



#### **USAGE**

6. The **LESSEE** must use the equipment in an careful and adequate manner and respect and comply with all political laws and other laws, prescriptions and regulations related to the possession, usage or maintenance of the equipment.

## **LOSS & DAMAGE**

- 7. The **LESSEE** will assume all risks with regard to the loss, theft, destruction and damage to the equipment for whatever reason and whether or not the risks are covered by an insurance.
- 8. In case of loss or damage to the equipment, the **LESSEE** will pay to **Geneq Inc.** the cost of repairing or replacing the equipment as specified by **Geneq Inc.**

#### **RETURN OF THE EQUIPMENT**

9. Upon termination or cancellation of this contract, the **LESSEE** will return the equipment to **Geneq Inc.** in good condition and in working order, with the exception of wear and tear resulting from an appropriate use of the equipment. The equipment will be returned at the **LESSEE**'s cost, to the same location where it was originally picked up.

## **INSURANCE**

10. The **LESSEE** is responsible for insuring the equipment against theft, loss and total or partial deterioration. Said insurance must cover at least the value of the equipment as indicated in Article 1.



## **OWNERSHIP**

11. The equipment is, will be and will remain at all times the exclusive property of **Geneq Inc.**, and the **LESSEE** will have no right, title or interest except those specifically provided for in this contract.

#### **DEFAULT**

- 12. In the event that the **LESSEE** does not pay the sums stipulated in this contract **(10) days** after the maturity date, or if the **LESSEE** does not comply with any other obligation under this contract, **Geneq Inc.** will have the right to use one or several of the following recourses.
- a) Declare the total amount due and payable immediately without notice or request to the **LESSEE**.
- b) Start proceedings against the **LESSEE** to recover all payments accumulated until then or thereafter.
- c) Take possession of the equipment without request or notice wherever it is located, without judicial decision or any other legal proceedings.
- d) Terminate the contract.
- e) Use other legal or moral remedies.

## **CANCELLATION**

13. This contract may be terminated without prejudice or formal notice, for any reason of force majeure or fortuitous event including, but not exclusively, war, insurrection, death or serious illness, severe accident or any other reason of the same nature beyond the control of the parties.
